Type: OPEN (you do not have to be a club member to fish)

When: Saturday, June 10, 2023, 7:00 am – 12:00 pm

Where: Lake Shelbyville, Bo Woods

Entry Fee: \$10 per person - Non-Member

\$5 per person - Member

NOTE: You are responsible for paying any lake/launch fees

AM Check-In: 6:00 am (*Trailering and bank fishing IS ALLOWED at this event and you may launch your boat after check in but CANNOT have lines in the water before 7:00 am.*)

PM Check-In: 12:30 pm: All lines must be out of the water and boats must CEASE FISHING at 12:00 pm. Weigh in scales will open at 12:30 pm and close at 1:30 pm. Must be IN LINE, with your one crappie, BEFORE 1:00 pm. Every person must check in at the weigh in line, with or without fish.

Weigh In: BIG CRAPPIE will be determined by weight

Payout: Payout 1st heaviest crappie = \$250, 2nd heaviest crappie = \$150, 3rd heaviest crappie=\$100
